

## OZNÁMENIE O ZÁKLADNEJ SADZBE PRE VÝPOČET REFERENČNEJ A DISKONTNEJ SADZBY

Dňa 1. apríla 2015 Európska komisia zaslala email, že **oznámenie zo dňa 9. marca 2015 týkajúce sa novej základnej sadzby pre výpočet referenčnej a diskontnej sadzby pre vymáhanie štátnej pomoci v Slovenskej republike zostáva na úrovni 0,34%**. V oznámení stanovená nová základná sadzba na úrovni **0,28%**, ktorá mala byť platná od 1. apríla 2015 **sa nepoužije**, vzhľadom k tomu, že bola výsledkom chybného indikatívneho výpočtu.

Dear Madam, Dear Sir,

**On 9 March 2015 a letter was sent to all the members of the Euro zone informing them that the base rate for the Euro zone changed to 0.28% as from 1.4.2015, as the average of the indicative rates recorded over the last known three months differed by more than 15% from the base rate in force.**

**Unfortunately, a calculation error was made for the month of February and the difference turns out to be only 14.66%. There is thus no change in base rate for the Euro zone as from 1.4.2015, it remains at 0.34%.**
